"POUNDING"

Before my days as a clergy in the Methodist Church, when I would hear about someone taking a "pounding," I hoped that no one was hurt too bad. I saw nothing good about giving or receiving a "pounding." Looking for "pounding" in the dictionary, the definition states, "repeated and heavy striking or hitting of someone or something, a rhythmical beating or throbbing." That pretty much covers the most common use of the word, "pounding."

As a young clergy, I experienced my first "pounding"! Today, some churches find themselves in precarious situations, including clergy and parishioners with hurt or angry feelings. One may feel as if they were "pounded" as stated in the dictionary. With Spring in the air and with Summer around the corner, I propose that we, the church, start "pounding" the pastor and others in the community! But do so in Christian Love.

I know that it is a strange ask for a Foundation president to suggest such a thing as "pounding," but for those who are a little older and lived in rural areas of The South, you do know what "pounding" and "Pounding The Preacher" are. "Pounding" is one of the greatest expressions of love that I have ever experienced. "Pounding" is the act of giving essentials to those who could not supply for themselves.

In the 1800s many preachers were poor rural folk who did not spend a lot of time at home and did not get a great salary. Some pastors were not paid at all (Parishioners- please do not get any ideas.). Some Methodist Pastors rode a circuit, leaving no time to care for animals and crops for food. To help the preacher and family, several times a year the congregation would perform a "pounding." Families of the church would surprise the preacher and show up with pounds of flour, sugar, butter, meat, firewood and whatever else they could spare. If the preacher did have animals, men would bring pounds of grain and hay as well for feed. "Pounding" is an expression of sacrificial love, no matter if you receive a "pounding" or you give a "pounding."

Growing up in a small town in South Carolina, my family would receive gifts of freshly picked tomatoes, ripe cucumbers, a sweet cantaloupe, and bushel baskets of beans. The community would give "the fruits of their labors" out of love. My grandfather taught me how to raise cantaloupe and honeydew melons. He would allow me to pick a dozen or more to sell on the roadside stand for summer spending money. Before the sales began, we visited with several older widowers who could not have a garden. We would give the ripest melons to them in Christian Love.

"Pounding" is a fun way to share God's love with others. One could "pound" a new or old neighbor, a bride-to-be, and yes, even your pastor. Even when "pounded" in jest, it can be a learning experience for others and a Spirit filled act of Christian Love for all.

As the pastor of Shady Grove UMC, in Irmo, I had the privilege of serving a rural community of multi-generational families. The parishioners were transitioning from a once rural community to a community newly populated with businesses such as Walmart and fast-food restaurants. One sweet parishioner in her eighties introduced me to "pounding." Mrs. Ernestine Bauknight shared tomatoes, cucumbers, and beans from her garden that she worked daily. She not just "pounded" me with delicious vegetables, but she also "pounded" me with a sacrificial selfless Christian Love. At the conclusion of my appointment at Shady Grove, Mrs. Bauknight gifted me with seeds from her heirloom green beans.

As I enjoy the Spring and look forward to the Summer, I plant a garden in hopes of sharing. But there is no greater feeling of the Spirit of Christian Love as I reflected upon my "poundings" and the seeds (green bean seeds and seeds of Faith and Love) to pass along as blessings to others.

"Giving" and "Receiving" are blessings. The Foundation is a steward of those blessings, and we witness every contribution and gift grow and shared as a gift of Christian Love, whether it is for a seminary scholarship, for a church mission, or for a music program. Every season of the year is a season of giving and "pounding." May God help lead us through this Easter Season and beyond fueled by a Spirit of Christian Love and Generosity. Therefore, go and "POUND AWAY"!
